Iron Bridge Closing Confirmed: November 14 – November 18

MassDOT has confirmed that the iron bridge will be closed the week of November 14 thru November 18, 2022 for resurfacing. Our Town Administrator will place the notice on the town website and ask that the Town Clerk send out a town-wide telephone message as the date draws near.

Public Forum at BSE Nov. 16 at 6:00 pm -- Should Buckland & Shelburne Share Police Services?

Residents of Buckland and Shelburne are invited to the first public forum to learn more about the opportunity to share Police Services between the two Towns. The forum will be held on Wednesday, Nov. 16 at 6:00 p.m. at the Buckland Shelburne Elementary School and by Zoom at <https://us02web.zoom.us/j/84014784520>.

Residents will hear from Town Officials and from Chief Gregory Bardwell about the motivation for why the Town's have begun looking into Shared Police Services as well as some of the anticipated benefits from the collaboration. Residents will get ample time to ask questions as well express their support or their concern about the proposal. Dates will be announced for follow up public forums in the next few weeks.

Moonlight Magic is on! Friday, November 25 from 4:00 – 9:00 pm

Clothing and Textiles banned from trash: State Waste Ban begins Nov. 1st

As of November 1, 2022, clothing and other textiles will no longer be allowed in the trash in Massachusetts. New state "waste ban" rules require textiles be kept out of the trash so they can be reused or recycled. Residents should place clean, dry clothing, textiles and footwear in a plastic bag and bring to a textiles drop off location. Never place textiles in a recycling bin.

What is banned from the trash and accepted in textile drop-off locations? Textiles are defined as anything from clothing (shirts, sweaters, pants) to footwear (sneakers, sandals, cleats) to accessories (bags, belts, hats) to linens (sheets, towels, fabric, and more). These items can be torn, stained, out of style, or missing a mate, but they must be CLEAN and DRY. Items that cannot be reused or sold in thrift stores are sorted, baled and sold to recyclers who make insulation, padding, and wiping cloths. To see a longer list of accepted items, please visit:

To retain their reuse value and avoid mildew contamination, all textile donations must be clean and dry. Keep them dry by placing in a plastic bag and tying it up. Textiles that are contaminated with mold, bodily fluids, insects, oil, or

hazardous substances may go in the trash. There are many local drop-off locations. Textile drop boxes accept the widest range of items; smaller, independent resale shops may be more restrictive in what they want. Some organizations will even pick up from your home.

Every municipal transfer station in Franklin County hosts a textiles drop box for their residents or permit holders. Some transfer stations might require access fees or annual permits. These 19 transfer stations are in: Ashfield, Bernardston, Buckland, Charlemont, Colrain, Conway, Deerfield, Greenfield, Heath, Leverett, Montague (Turners Falls), New Salem, Northfield, Orange, Rowe, Shelburne, Warwick, Wendell, and Whately. In addition, textile recycling is now accepted at local Salvation Army Thrift Stores.

The 2030 Solid Waste Master Plan by the Massachusetts Department of Environmental Protection (MassDEP) aims to reduce solid waste disposal statewide by 30 percent over the next decade, from 5.7 million tons in 2018 to 4 million tons in 2030. MassDEP is expanding the state's current waste disposal bans by adding textiles to the list of materials banned from disposal or transport for disposal in Massachusetts. Clothing and textile products amount to 6% of all material going into U.S. landfills and incinerators...that's 230,000 tons annually in Massachusetts alone! 95% of all used clothing, footwear, and other household textile products can be reused or recycled, yet only 15% of reusable textiles are currently recovered from the waste stream. Trash disposal capacity is extremely limited in Massachusetts. Diverting recyclable (and compostable) materials from the trash conserves our limited landfill space and saves money. The few remaining landfills in the state are scheduled to fill up and permanently close within a few years.

Most of the "waste-to-energy" trash incinerators in Massachusetts are operating at full capacity. Earlier this year, the two waste incinerators in western Mass went bankrupt and closed; that trash is now being sent to landfills in faraway states such as Pennsylvania and the Carolinas. Trash disposal is expensive for municipalities and waste haulers, and due to longer travel distances, trash costs are rising.

Town Clerk News: November 8th State Election updates:

As of this writing, 467 Shelburne voters have participated in the Early Voting process in Shelburne! And I anticipate a closing total of at least 600 "Registered Shelburne Voters" will have already voted by the time the November 8th Election Day arrives, with another 300-400 voters expected to show up on Election Day itself! If these numbers hold true, this will be the second largest voter turnout in recent history, at least in the almost nine years since I've held this elected position.

I, and all my election workers, are anticipating a busy, but great Election Day. And we're hoping that we'll see those of you who haven't already voted, "at the polls" on November 8th!

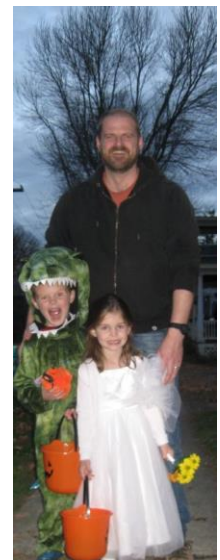
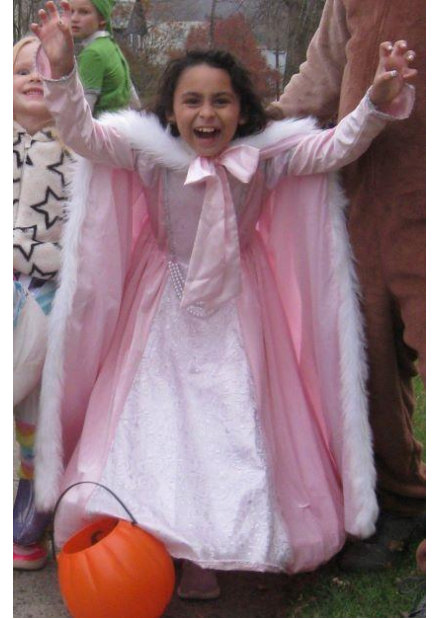

Community Preservation Act will be Question #5 on the ballot November 8

Voters in Shelburne will have the opportunity to vote on whether or not to adopt the Community Preservation Act (CPA) in Shelburne at the November 8 state-wide election. CPA will be question 5 in Shelburne following four state-wide referendum questions. (In other Franklin County communities, Question 5 is an advisory question about carbon pricing. In Shelburne, the Carbon Tax question is #6.) CPA is a local option tax that, if adopted, allows Shelburne to add a 3% surcharge to local property taxes to raise funds for community improvement projects – historic preservation, open space, recreation & community housing. Funds raised locally can be matched up to 100% with state funds generated from real estate transfer fees. **For more information on CPA, go to www.Shelburne-cpa.org**

Highway Department News: Bagged Leaf Pickup in the Village on Nov. 14

The Shelburne Highway Dept. will be collecting bagged leaves in the Village on Monday, November 14 (weather permitting). Bags containing leaves only should be placed curbside by 7:00 am.

Iron Bridge repaving & repair – **Tentatively scheduled for the week of Nov. 14.** Mass. Dept of Transportation will repave the Iron Bridge deck if the weather cooperates. The project will take approximately one week and will close the bridge to traffic. Repair of the Iron Bridge sidewalk has not yet been scheduled.

Do Rising Fuel Costs and Upcoming Electric Rates Have You Worried?

Greetings Fellow Shelburnites,

It's time to dig out our winter slippers and favorite toasty sweaters! If you're like me, you're concerned by the recent news that National Grid's electric rate just went up three-fold. In mid-November, Eversource will release its new rate. Luckily, Shelburne homeowners may be somewhat buffered due to the 41-month aggregation rate that Shelburne and neighboring town's officials negotiated with DYNEGY and that was initiated in August of 2020. All Shelburne residents were automatically put on the aggregation rate, but were given the opportunity to opt out. If you opted out, you might want to consider opting back in. If you're not sure if you're in the program, look under "Supplier" on your bill, which would read "DYNEGY- SHELBURNE AGG."

To learn more about Electricity Aggregation, go to the Town of Shelburne, MA website and use the search feature. Search on the term "aggregation" and browse the entries for more information. The entry posted on November 16, 2021 describes how to opt in. It also describes how to find out if you may qualify for Eversource's Discount Rate which is available even if you're included in the aggregation rate.

Fuel Assistance: Speaking of discount rates, people at or below 60% of the median income rate are eligible to apply to get assistance with fuel bills. To learn more, visit the website of Community Action Pioneer Valley at <https://www.communityaction.us/> (browse all energy topics, including "fuel assistance"). If accepted into the program, even renters whose "utilities are included in rent" may be issued a check to help with their fuel costs.

Reduce the need: You may be able to reduce the amount of fuel your dwelling needs by having a home energy assessment through the Mass Save program. There are many incentives that vary by three income ranges (a moderate income range was recently added), but there is something for everyone. Go to our Shelburne-specific web portal to Mass Save, "masssave.com/Shelburne." (The "Get Started" icon and Shelburne specific phone number enables you to register for an assessment. I suggest browsing the entire webpage before registering, which enables you to learn more about the categories that apply to you and your home, rental unit or small business.)

Questions? Please, keep in mind that I'm happy to help you find answers to your questions about the Mass Save program. Cycle of Memory Documentary: November 8 at 5:30 pm at the Senior Center

Join the Senior Center for a special intergenerational screening of "Cycle of Memory": the new award-winning documentary about two siblings' bicycle adventure to find memories of their grandfather lost to Alzheimer's. The film is 72 minutes long and will be followed by a Q&A with the film-maker. About the film: Mel Schwartz escaped the Great Depression on a bicycle adventure he'd remember for the rest of his life. But when Alzheimer's takes Mel's memories away, it's left to his grandkids to recreate the life-changing bike trip and find those memories again. Guided by old photographs of the 1945 trip, they search for places aged by time. But while searching for Grandpa Mel's past, the two are confronted with their own fraught history. If they're going to complete the turbulent journey, they'll have to face their own emotional potholes and tumultuous relationship. With the help of a grandmother learning to live alone for the first time, Mel's lifelong friend and co-adventurer on the bike trip, and a family collection spanning 1950s film reels to 1990s video tapes, Cycle of Memory explores the importance of intergenerational connection, healing painful pasts, and leaving a meaningful time capsule for the future. **Please call 625-2502 to pre-register.**

The program enables participants to reduce the fear of falling by learning to view falls as controllable, setting goals for increasing activity levels, making small changes to reduce fall risks at home, and exercise to increase strength and balance. The curriculum includes group discussions, mutual problem solving, role-play activities, exercise training, assertiveness training, and a few homework assignments. Participants learn about the importance of exercise in preventing falls and practice exercises to improve strength, coordination, and balance. Planning Board Learns About Climate Smart Forestry

At its October 18 meeting the Planning Board heard a presentation from Andrew Randazzo, a Forest Ecologist from Mass Audubon. Andrew spoke on climate-smart forestry, and how communities can adapt to our changing climate.

Climate changes impact forests by extreme weather events, increased storm frequency and intensity, elevated drought risks, less snow, and rising sea level. Other forest stressors include more pests, such as the woolly adelgid which has affected many hemlock trees in our area, increased numbers of invasive plants, and reduction in tree species habitat. Climate-smart forestry involves both adaptation (maintaining forest health) and mitigation (carbon sequestration).

In the future, the Planning Board will be applying for a Municipal Vulnerability Grant and climate-smart forestry could be one of the components. Shelburne Police Dept. Update

If you are traveling in Buckland in November, be aware of these construction-related road closures:

A 24-hour closure to THRU traffic on Conway, Summer, South Streets and Conway Road will take effect Monday, Nov. 7th and will last approximately 10 weeks. The work is part of an ongoing Conway Street road reconstruction project. Local traffic on either side of the closures will not be impacted but traffic to and from Conway Road in Buckland etc will not be able to access Shelburne Falls from this route. Businesses on Conway Street, Depot Street and Ashfield Street will remain open and accessible during the construction.

Work Area #1: Gardner Falls Road – Culvert Replacement

South Street will be closed where Gardner Falls Road meeting South Street and no thru traffic will be permitted. There is an anticipated stop-work date in mid-December until Jan. 1st during which the road will be temporarily re-opened to thru traffic.

Work Area #2: South Street at #18, #19, & #21 South Street – Culvert Replacement

South Street will be closed in the vicinity of #18, #19, & #21 South Street and no thru traffic will be permitted. The work will begin after Jan. 1st and will last approximately four weeks.

Regional Mattress Recycling Program Begins October 24th

The Franklin County Solid Waste Management District is working with five towns to accept clean and dry mattresses and box springs for recycling. This program is open to residents in all District towns. The program is only for clean and dry fabric covered mattresses and box springs, including foam and crib mattresses.

Beginning on October 24th residents must take clean and dry mattresses and box springs to a recycling program in Bernardston, Colrain, Deerfield, Montague, or Wendell. The MassDEP now prohibits all clean and dry mattresses and box springs from going into the trash for landfill disposal and these will be rejected if brought to a transfer station for disposal.

All regional mattress recycling sites charge \$35 per mattress or box spring regardless of size. Check the specific information for each site before bringing a mattress for recycling. Site addresses, hours, and payment information is below:

- Bernardston Transfer Station, Nelson Rd, Thursday and Saturday 7 am – 5 pm. Checks only.
- Colrain Transfer Station, Charlemont Rd, Saturday 8 am – 4 pm. Cash or checks.
- Deerfield Transfer Station, Lee Rd., Tuesday, Thursday, & Saturday 8:30-4. Checks/ money order.
- Montague Transfer Station, Sandy Lane Turners Falls, Wednesday 7-2:30 Saturday 7-12. Checks only.
- Wendell Transfer Station, New Salem Rd., Tuesday 12-5:50 & Saturday 7:30-3:30. Cash or checks.

Franklin County residents can also use the Greenfield Transfer Station on Cumberland Rd, which is open Tuesday through Friday 11-2:30 and Saturday 7:30-2. Mattresses and box springs cost \$30 each plus a \$5 host fee for out of town residents.

Shopping for a new mattress? Ask your mattress seller if they will take away your old mattress when they deliver the new one. Some retailers will include this service as part of the delivery, and some charge a fee.

Hi Everyone. The hurricane season has past and the winter weather will soon be upon us. Winter can bring us some spectacular snowy scenery and lots of outside fun. It can also, as we all well know, deliver some unpleasant episodes of excessive snow and ice, which often leads to power outages. FEMA has a good saying, "Preparing Makes Sense". The time to start thinking about cold weather issues is now.

FEMA's three part recommendation includes:

1. KNOW YOUR RISKS. Prepare for the risks where you live.
2. MAKE A PLAN. Prepare yourself and your family before disaster strikes.
3. TAKE ACTION. Be ready to respond to and recover from a disaster.

Open Space Committee – November is the time to hike!

“Thank you” to all who came out and enjoyed our four guided, educational hikes this year! Want to go hiking when the trails are not crowded, the weather is not hot and humid, there are still a few leaves clinging to the trees, and there are no bugs or even snow on the trails? November can be the perfect time to hike. Climbing to the Shelburne Fire Tower on a hot summer afternoon can be unbearable, but climbing in November can be a truly enjoyable and peaceful experience. Be aware, however, if we have some unseasonably warm days in November, disease bearing ticks can still come out to play.
